Norsk Høstfest grants to the Concessionaire, and the Concessionaire accepts from Norsk Høstfest, the nonexclusive privilege of maintaining a foods and/or beverage concession in the North Dakota State Fair Center at the North Dakota State Fairgrounds.

All rules and regulations in the Food Concessionaire Invitation are part of this contract, as though fully set out herein. Food Concessionaire must have three persons with proof of certification must be present at all times in each food operation who have completed and passed the temporary food safety training conducted by the First District Health Unit. Safety training will be held at 1 p.m., Tuesday, September 25, on the Skien Mezzanine. I agree to remain open for business until 8 p.m. Wednesday through Saturday. Vendors in Stockholm Hall will remain open until 10 pm Wednesday-Friday. I will not begin dismantling my booth/area until 8 p.m. Saturday, Sept. 29, 2018.
